- D. Technology Mr. Fitzgerald reported the meeting was held on April 4. Updates from the Technology department were discussed.
- E. Personnel Mr. Painter reported that Mr. Griscom discussed the necessary internship hours. Also discussed was the method to select the next JSHS principal. Applications are being reviewed hoping to find someone with principal experience. JSHS teachers have been invited to meetings to share the criteria they deem most important in new leadership. This information will be shared with the interview team. The assistant principal/dean positions will be filled after securing the new principal so that person may have input on the decision.
